Authors are asked to submit contributions in the following format:

- It is expected that authors will submit carefully written and proofread material. Spelling and grammatical errors, as well as language usage problems, are not acceptable in the final submission. There is no strict limitation to the number of pages, but it is suggested that the paper length should not exceed **6000 words** or **8 pages**.
- Papers are to be prepared in **American or British English**, but contributors should use one consistently throughout. Technical terms should be explained. Acronyms should be written out at their first appearance.
- Use Microsoft Word for text.
- Use 11-point Time Roman font and single space for text except table, figure and reference use 10-point Time Roman font.
